## **Housing Regulation**

Students whose actual local residence is with parent(s), legal guardian(s) or close relative(s) within twenty-five miles of campus, as defined in the University Housing Regulation, may request an exemption from the University Housing Regulation prior to signing the housing contract. Students requesting an exemption must register their address with Housing and Residence Education.

### **Columbus Campus**

Students who matriculate to The Ohio State University, Columbus campus during the same year they graduate from high school (or educational equivalent) are required to sign a housing contract that is effective for two (2) full academic years, autumn through spring semester, or for such a portion of the academic year(s) as may remain at the time this contract is signed.

#### **Wooster Campus**

Students who matriculate to The Ohio State University, Wooster – ATI campus during the same year they graduate from high school (or educational equivalent) are required to sign a housing contract that is effective for one (1) full academic year, autumn through spring semester, or for such a portion of the academic year as may remain at the time this contract is signed.
